Vouchers, checks, and financial reports for October 2020 were approved. This was done by approval of the consent calendar by motion of Trustee Banks and

#### Management Update

- The board was made aware that the Stifel transfer to the County of Kern was \$109,528.36
- The board was made aware that staff shredded records that were within the guidelines of the District's Record Retention Policy.

# Security Camera Policy

Manager Unruh brought a new policy for the board to review. This was a policy that will provide guidance for the placement and monitoring of the District security cameras. The board reviewed the policy and asked that it be brought back at the next regular meeting for final consideration. No action taken.

### **Assistant Manager Position**

The board reviewed the consideration of activating the Assistant Manager position. They reviewed the position classification and discussed the actions and standards that were listed. No changes were made.

Chairman Braun took the board into closed session at 12:50pm to discuss a Public Employee Appointment for the Assistant Manager position as allowed as a safe harbor under section 54957 of the California Government Code. The board came out of closed session at 1:45pm. No action taken; the board will continue this discussion at a special board meeting scheduled for Thursday December 3, 2020.
